Madam Clara Bassey U. Offiong of Cross River State, Nigeria had a strong devotion to the Catholic Church, the Blessed Virgin Mary, and spiritual friendship with Mother Angelica which culminated in a lasting legacy of ongoing evangelization. We met Clara's daughter, Elizabeth Henshaw, at a recent EWTN Legacy Giving Estate Planning Seminar in Connecticut. Elizabeth is a faithful donor and friend of EWTN and shared her mother's story with us.

Late in life, Clara moved to the U.S. from Nigeria. She eventually lost her eyesight to glaucoma. While she was disappointed by the loss of her physical sight, it led to a gain in spiritual sight with the help of EWTN.

While searching for a television program for Clara to listen to, Elizabeth found EWTN for the first time. It changed her mother's life.

Clara loved Mother Angelica's voice and listened to EWTN every day. Clara began to share Mother Angelica's wisdom and spiritual insights with her nurses, family, and friends.

Clara wanted to support the mission of Mother Angelica and EWTN and expand evangelization in Nigeria. Upon her passing, Elizabeth honored her mother by working with EWTN, the Archdiocese of Calabar, and the Diocese of Abuja, to donate her home to be used as an Archdiocesan Media Center. 5 ways to avoid despair in difficult times



Glory to Jesus Christ, Glory to Him forever!

You will be challenged during sickness and before death to trust in God's mercy. One

way to avoid despair in difficult times is to plan now, turning to Christ and the Church's teachings, with legal documents that integrate your faith.

Health Care Powers of Attorney & Living Wills

Powers of attorney are documents which authorize another person to make medical decisions for you when you are incapacitated. By contrast, a Living Will is a document that informs and directs a treating physician about your medical decisions regarding end-of-life care.

Caution Regarding the Use of Living Wills

The Catholic Church teaches that you should know the individual making an end-of-life decision for you. A Health Care Power of Attorney is preferable to a Living Will because you have no idea who the treating physician will be to enforce your wished. A Living Will also does not consider advances in medical treatment, and the document restricts a health care agent's authority to make medical decisions for you.

When drafting a Health Care Power of Attorney, you may wish to include the following faith-based provisions in the document:



Administration of Nutrition and Hydration

Catholics should prayerfully consider including a provision in a Health Care Power that requests the administration of nutrition and hydration *except and unless* the administration (1) would worsen one's medical condition, (2) cause significant pain or discomfort, or (3) not assimilate into the body.

Request for Sacraments

Include a request for
Anointing of the Sick, Confession, and
Holy Communion. By making these
requests, you are exercising your First
Amendment right to "free exercise of
religion" under the U.S. Constitution,
which may offer the opportunity to
obtain a court-ordered injunction if your
request is denied.

One can also explicitly request in the Power of Attorney the **Apostolic Pardon** from the priest administering Sacramental Anointing, thereby receiving a plenary indulgence and pardon for all temporal punishment provided one is in the state of grace and the usual conditions are met.



Directive Forbidding Physician-Assisted Suicide

Include a directive forbidding physician-assisted suicide, and a declaration that overrides the signing of a MOLST/POLST (Medical or Physicians Order for Life Sustaining Treatment) so that the Health Care agent's authority is in no way limited by a subsequent medical order.



Provisions Concerning Pregnancy

Language may also be included that protects both the life of an unborn child in utero and the life of the mother when the mother has already been declared legally brain-dead.



Avoidance of Unethically Derived Medical Treatments

Finally, consider including a provision rejecting medical treatments derived from immoral and unethical medical practices, including abortions and embryonic stem cell research.

Will you trust in the Lord?

Remember the Lord's words: "Fear is useless, what is needed it trust." (Luke 8:50) Each of us must carry our cross with the Lord all the way to Calvary one day receive the crown of holiness and be clothed in light for all eternity. Start now prepare the necessary documents while trusting in the Lord's mercy and in His teachings through the Church.

Estate and Personal Planning Seminar, Phoenix, Arizona

The EWTN Legacy Giving Team hosted two Catholic Charitable Estate and Personal Planning Seminars in Phoenix, Arizona the weekend of the EWTN Family Celebration on September 30 and October 1, 2022. These luncheon seminars provided EWTN Family Members with information pertaining to estate planning, charitable giving strategies, and end of life issues. Similar to our popular virtual seminars, these luncheons also provided attendees with an added opportunity to meet and ask questions of the Legacy Giving Staff and local Estate Planning Attorney Robert Way. The no- cost, no-obligation seminar offered important estate and gift planning information in a relaxed setting over lunch.

The seminar began with an update from Karen Silva about current events and developments at EWTN. The Director of the Legacy Giving Program, Ryan Flood, then discussed bequests and beneficiary designations, qualified charitable distributions from IRAs, Charitable Gift Annuities, and other gift planning strategies and ideas. Estate Planning Attorney Robert Way shared information from a legal perspective, including Catholic provisions for planning documents such as Advance Medical Directives and the Durable Power of Attorney. Robert also discussed how to integrate one's Catholic faith into their planning documents.

The 24 attendees spoke positively about the seminars. One stated, "I really appreciated that you held this in person so I could meet you and ask questions. You discussed things I had never thought about, and I found it very helpful." Several of the guests have scheduled follow-up calls and visits from Legacy Giving Team members for individual planning.
